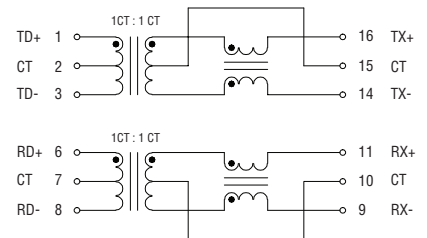

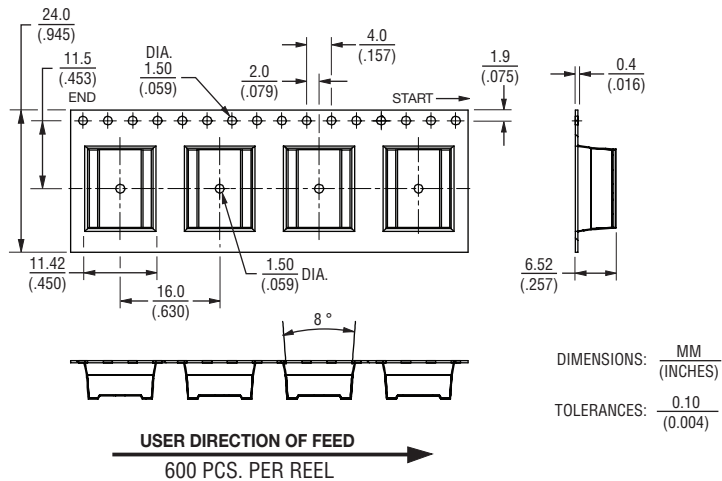
Recommended Layout
