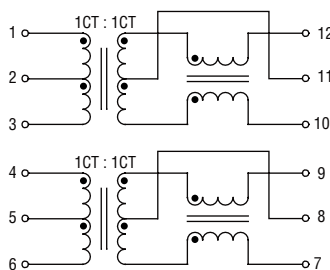

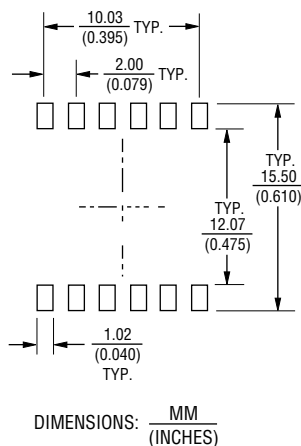

### Recommended Layout

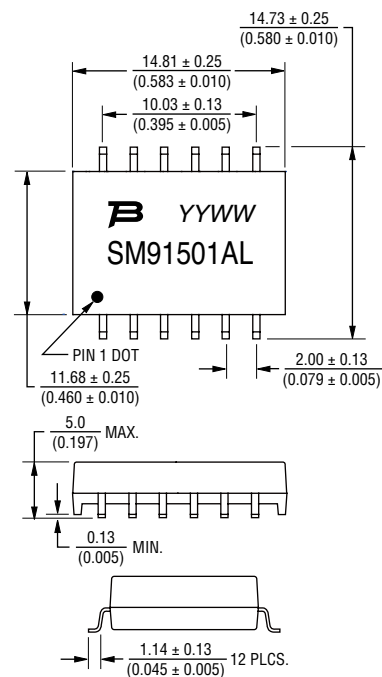

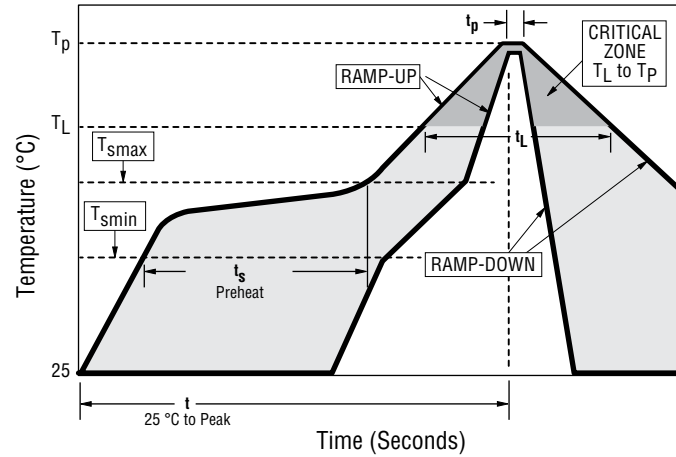

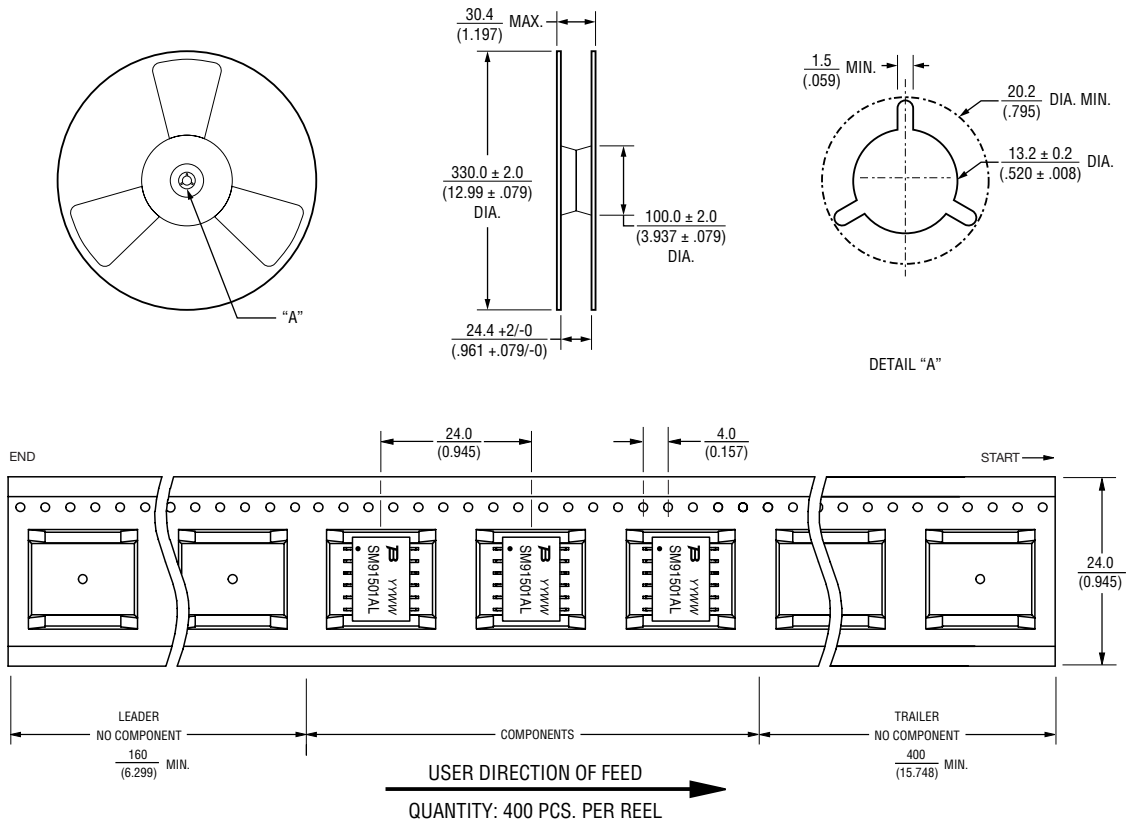
